Editorial Introduction

These minutes cover Court of Honour meetings held during the 1950s. The Court of Honour (COH) was held on a regular basis and involved the Patrol Leaders (PLs) discussing the Troop's affairs with the Scout Master (SM). Some of the Assistant Scout Masters (ASMs) were often present and, occasionally, specific Scouts might be asked to attend. The meetings were usually chaired by the Troop Leader (TL), and the minutes were taken by an appointed scribe (usually one of the Patrol Leaders). It should be noted that minutes were not always taken and that there were more COH meetings held than are identified here.

During the period covered in this minutes book, the Troop Leaders were Andrew Gunn (May - June 1951), John Cook (March-Sept. 1952), Andy Whiteford (1953-May 1954), Douglas Brown (May – Sept. 1954), Ian McFarlane (Sept. 1954 – Sept. 1955), Sandy Whiteford (Oct. 1955 – Oct. 1957), and John Nisbet (Nov. 1957- Sept. 1959).

The Scribes were George G. Crawford (1951- Aug. 1952), J. Brian Hodgson (Sept. 1952), Douglas Brown (Sept. 1952-Oct. 1953), Ian McFarlane (Nov. 1953 - June 1954, Neill Cook (Sept. 1954- March 1955, James Harvey (Sept. 1955-Jan. 1957) and Trevor Jones (Feb. 1957 – May 1959). The meetings were often held in the Session Room of Finnart Church on a Friday night after the Troop Meeting. However, some COH meetings were held in private houses. Each COH Meeting began with everyone renewing the Scout Promise.

During this period, Victor Clark, Brian Hodgson and Ian Blake were Scout Masters. The following are Patrol Leaders who were members of the Court of Honour during the period covered in this minutes book.

It is noticeable that during the period 1950-55 most PLs remained in post for 1-2 years, which is indicative of a troop that is relatively balanced in terms of the age range of Scouts present. However, there is a marked difference for the period 1956-59. Many of the PLs appointed in 1956 and 1957 were clearly promoted at a relatively young age, as they remained 'in post' for 3-4 years. Indeed, no new PLs were appointed in either 1958 or 1959. This was also the case for most of the seconds that were appointed in 1956 and 1957. The fact that the Troop had a very young average age in 1955 and 1956 makes the achievements of that period all the more impressive. For example, the Troop won the Shannon Cup in 1956 and continued to dominate the District Signalling Competition, while substantial Summer Camps were introduced in 1955 and were increasingly ambitious in terms of where they were held. By 1959, the average age of the Troop had increased and the Troop now contained a strong contingent of highly experienced Scouts. On the debit side, it meant that many of those Scouts resigned in 1959 or 1960, just at the time that Bob Miller took over the troop from Ian Blake. As a result, Bob's first two years as Scout Master were to prove quite challenging as the Troop experienced a slump in numbers caused by a combination of older Scouts leaving and a scarcity of new recruits from the Wolf Cub Pack.

The S.M.³ informed those attending that Mr Douglas Parish⁸ had withdrawn from the post of Junior A.S.M.⁹ The reason, he said, were too deep to go into great detail.

The main item on the agenda was the Parents Night.¹⁰ The subject of what type of ticket to issue was now brought up. Several suggestions were put forward and finally a form of donation ticket was unanimously agreed upon. Entertainment was brought up and such forms as a mouth organ band¹¹, choir¹² and a play¹² were received with enthusiasm.

The more serious side of entertainment was forwarded and the S.M.³ had already a list and suggested that the six stages of scout life should be staged by several scouts¹³.

The annual parties were talked of and, as last year, there would be two parties. The date of the junior party was uncertain and either Tuesday the 18th or Thursday 20th December were suitable¹⁴. Partners were to be decided upon at the next scout meeting.¹⁵

Between the 21^{st} and 28 December were the dates suggested for the senior scout party. 16

The S.M.³ said our troop funds were very low and the question of raising money was quite an easy one with a little cooperation from the scouts. He then suggested a sale of work in March or thereabouts.¹⁷

Tickets for all scout functions in our troop would be printed by the S.M.³, who had his own home printing machine. The S.M. also suggested that membership cards should be issued to every scout in the troop.

Someone brought up the subject of kilts for the whole troop, but it was a very doubtful proposition.¹⁸

To equip the troop with a pipe-band 19 would cost the troop about £80 20 . The band would consist of four pipers and three drummers. To raise the required amount, loans would have to be received from some source.

On the next day, four chanters were to be obtained from Russels, West Blackhall Street²¹, and George Crawford⁷ offered to collect them. Mr Clark³ said that we would have to have coaches or a coach from the R.N.T.F²² pipe band to teach us how to play the chanters and drums.

A membership card for the members of the championship patrol was agreed upon and would be printed by the $S.M.^3$

A certain hut²³ in Kerr Place²⁴, Margaret St. might be allotted to the scouts if and when the squatters in the huts were shifted. Mr Clark had been to see Mr. John Kerr²⁵ about the prospect of obtaining a hut, but it was clear that the scouts could not occupy a hut while there were squatters in the vicinity.

We were informed that the cub party was to be held on 26th November and the troop had been invited along to the Union Street Church troop²⁶ for the night.

It had been a very interesting night and two hours had passed swiftly by and some of us had homework to do, so we departed from Mr Clark's home with happy prospects for the future.

Editorial Comments for COH Meeting (late September 1951 est.)

- 1. The month and year were not specified. However, there are several indications that this COH meeting took place in late September 1951. To begin with, Andrew Gunn was appointed T.L. at the start of May 1951, while Douglas Parish was still present as Junior A.S.M on the 14th September 1951. Parent's Night was held on the 13th December 1951 and there were frequent rehearsals throughout October and November 1951 involving the choir and the play (as proposed in the minutes). Therefore, it seems likely that this COH meeting took place during the last half of September 1951. One curiosity is the absence of the younger Patrol Leaders (Douglas Brown, Alistair Duncan, Douglas MacNeill and David Slater).
- 2. Victor Clark's home address was 50 Brougham Street, Greenock.
- 3. Victor J. Clark had been Scoutmaster (S.M.) since restarting the 70th Troop in 1947. He had also been a 70th Scout throughout most of the 1930s. It is estimated that he was aged about 29 or 30 in 1951.
- **4**. Brian Hodgson was identified as a P.L. at the start of 1950. However, he was not in charge of a patrol and it is believed that he was acting the role of Troop Leader. It is possible that he was not yet old enough to be promoted as such. He was officially promoted to Troop Leader in September 1950, then to A.S.M in January 1951. It is estimated that he was aged 17 in 1951.
- 5. Andrew W. Gunn was present in the earliest surviving photograph of the revived 70th Troop taken in 1949 (2 years after it had restarted). At this point he was aged about 14 and could well have been present when the troop restarted. By 1950, he was P.L of the Wolf Patrol. He was then promoted to Troop Leader at the beginning of May 1951 (probably when he reached the age of 16).
- 6. John Cook was present in the earliest surviving photograph of the revived 70th Troop taken in 1949 (2 years after it had restarted). At this point, he was aged 12. In January 1950, he was promoted to P.L of the Seal Patrol a few weeks before his 13th Birthday. He was then promoted to Troop Leader at the in March 1952 once he reached the age of 15).
- 7. George Crawford was present in the earliest surviving photograph of the revived 70th Troop taken in 1949 (2 years after it had restarted). At this point, he was aged about 13 and so might have joined the Troop when it was restarted in 1947. It is likely that he was promoted to PL of the Curlew Patrol in September 1950. By 1951, he would have been aged about 15.
- 8. As Douglas Parish was classed as a junior ASM, he was probably aged about 17 in 1951. Douglas was responsible for introducing the singing of 'The Lord's My Shepherd' at the end of campfires a tradition that lasted for several decades. After he resigned from the Troop, he became a prominent youth worker in Greenock.
- 9. It is not known whether the position of Junior A.S.M. was an official one or not. The title appears to have been used for boys that had resigned as Patrol Leaders and joined the Scouter team, but were still within the Scout age range. Presumably, it was not possible to apply for an ASM's warrant until you were no longer of Scout age.
- 10. In the 1950s, a Parents Night appears to have been organized on an annual basis during the Autumn. The Parents Night in 1951 was held on Thursday 13th December. Rehearsals for the Parents Night were undertaken during most troop meetings throughout October and November 1951. These focused on choir practice and the play.
- 11. It is not known whether this was included in the eventual programme or not.
- **12**. Several rehearsals were carried out for both the choir and those performing in the play throughout October and November 1951.
- 13. It is not known for certain whether this was the topic for the play. However a play was certainly performed and it seems highly likely that this would have been the theme. However, it is not yet known what is represented by the 6 stages of Scout life.
- 14. It ended up being on the Thursday 20th December.
- 15. A vote was eventually held amongst the Scouts on the 19th October 1951. It was decided to invite partners to the senior scout party, which would be more like a dance. No partners would be invited to the junior party, which would be more like a party focusing on games.
- **16**. The eventual date was Thursday 27th December 1951.

- 17. There is no evidence of a Sale of Work taking place in March 1952, but that does not mean it did not take place.
- 18. Presumably it was deemed too expensive to provide kilts for all the Scouts, or impolitic to insist that parents purchase kilts for their sons. The wearing of kilts did not become compulsory in the troop until the late 1960s when the uniform requirements were changed with the Advance Party Report.
- 19. Presumably, this had been an ongoing discussion at previous COH meetings. The proposition appears to have been a serious one, but there is no clear evidence that a pipe band was ever properly formed within the 70^{th} .
- 20. £80 in 1951 would be the equivalent of about £3200 today (2023).
- 21. Hector Russells was a prestigious Greenock shop that sold Highland clothing, as well as School, Scout and Guide uniforms. It clearly sold bagpipes in the 1950s as well. It has not yet been established when the Greenock business closed down.
- **22**. Royal Naval Torpedo Factory. The R.N.T.F. was established in 1907 and was fully closed in 1969. Only a few of the original building remain.
- 23. No details are known about the hut. One possibility is that it was a temporary hut built during the war to accommodate servicemen. Several of these were 'taken over' by squatters after the war due to the lack of available housing. Another possibility is that it was one of the temporary, prefabricated houses that were built after the war for civilians whilst rebuilding work was being carried out. This too might have become empty and taken over by squatters. The COH account indicates that several such huts were present. A third possibility is that it was a hut that was built for the territorial army (see notes 24 and 25).
- 24. There is no evidence of a Kerr Place close to Margaret Street in either current maps or maps of the time. Following a discussion involving Kenneth W. Paton and Tommy Boag in July 2023, it was concluded that Kerr Place might have been misinterpreted by the Scribe and that Victor Clark had been referring to Kerr's Place, meaning Kerr's property, in which case the location of the huts was part of the garden behind John Kerr's house on the east side of Margaret Street between the Esplanade and Eldon Street (see note 25). The house was requisitioned during the war and it is believed that the ground behind was used by the territorial army after the war.
- 25. John Kerr (1885-1972) was the wealthy owner of the property at the corner of the Esplanade and Margaret Street (Heywood, 1 Margaret Street). He was born at the address and his father was Daniel Kerr, a shipowner. John grew up to become an internationally renowned cricketer who played for Glenpark Cricket Club and Scotland; he represented Scotland for 26 years! His name was frequently to be found in the Sports columns of the Greenock Telegraph. He was also a philanthropist and funded Kerr Hall at St. George's Church, George Square for the use of young people. He also provided the money for the Margaret Street Trust to support Greenock Scouting. That money contributed to the purchase of the Everton Campsite. Furthermore, he was a member of St. George's Church and Captain of the 7th Greenock Company of the Boys Brigade for 40 years. His name is included in the Oxford Dictionary of National Biography.
- 26. The Union Street Church was close to George Square. It was constituted in 1843, but demolished in 1992. Flats now stand on the original site. The 7th Renfrewshire Scouts met at the Church during the 1950s. There is no record in the Troop Log of a joint meeting taking place in November or December 1951. However, joint meetings did occasionally take place between the 7th and the 70th.

An announcement was made to the effect that T.L. John Cook¹¹ and P.L. G. Crawford¹² had left the Troop and these positions had to be filled. The appointment of a new T.L. was not considered and the S.M.⁴ intimated that it was being left over for reconsideration about Christmas.¹³

There were two proposals for the vacant positions of Patrol Leader of the Curlews.

- i) John Ross¹⁴ (second of the Wolf Patrol)
- ii) Jim Whitefield¹⁵ (second of the Curlew Patrol)
- J. Whitefield was appointed P.L. by 3 votes to 2.

The S.M.⁴ and A.S.M.⁵ were both in agreement with the Court's decision so Whitefield was to be appointed.

A new second was now to be appointed and again two proposals were made: Neill Cook 16 and Willie Bain 17 .

After a short discussion, it was decided that N. Cook¹⁶ was the Scout for the job and W. Bain's¹⁷ nomination was withdrawn.

New patrols were decided on 18 and are seen below.

It was decided that as well as a monthly Patrol Champions, there would also be a Yearly Champions, who would receive a set of medallions¹⁹, one for each member.

The Champions of the Year were to be decided by awarding the following points at the end of each month:

Champions of the Month : 6 pts.
Runners up : 5 pts.
Third : 5 pts.
Fourth : 3 pts.
Fifth : 2 pts.
Last : 1 pt.

The Court was then closed by the S.M.³

Editorial Comments for COH Meeting (4th September 1952)

- 1. The Court of Honour was held at Brian Hodgson's parental home of 81 Newton St., Greenock.
- 2. See note 7 for September 1951 regarding George Crawford.
- 3. The log book lacked entries covering an 11 month period from October 1951 to August 1952.
- 4. See note 3 for September 1951 regarding Scout Master Victor Clark.
- 5. See note 4 for September 1951 regarding Assistant Scout Master Brian Hodgson.
- 6. Alistair Duncan is believed to have joined the 70th Troop in 1948, not long after it was restarted in 1947. He was promoted to Second in September 1950, then to PL of the Fox Patrol in June 1951 at the age of 13. He was Captain of the 70th Football Team which won the District Football Competition in 1951 and was also a successful participant in the District Ambulance and Signalling Competitions.
- 7. David Slater was John Slater's younger brother and probably joined the Troop in 1948. He was promoted to PL of the Seagull Patrol in September 1950 at the age of 13. It is thought that he resigned as PL in November 1952 at the age of 15 and joined the Scouter Team as an Acting ASM.

 8. Andrew A. Whiteford initially joined the Scouts in Rothesay, then joined the 70th when the family moved to Greenock in late 1951 or early 1952. He was promoted to P.L. of the Seal Patrol in March 1952 when he would have been aged about 15. In 1953, he was promoted to Troop Leader and remained as T.L. and PL of the Seal until June 1954 when he resigned both positions and joined the Scouter team as an Acting ASM. There is evidence to suggest that he had gained his ASM's warrant by November 1955, by which time he would have benn aged 18.
- 9. Douglas Brown was Senior Sixer in the 70th's Wolf Cub Pack and was 'head hunted' from the 59th by Betty Nelson when she restarted the Pack in 1947. Douglas moved up to the troop at the start of the 1949-50 session. He was promoted to PL of the Falcon Patrol in June 1951 at the age of 13 and remained PL for 3 years until May 1954.
- 10. It is not known when Douglas MacNeill joined the Troop, but it was probably during the second half of 1949. He was promoted to Second in June 1951, then to PL of the Wolf Patrol possibly at the start of the 1951-52 session. He was probably aged 14 in 1951.
- **11**. See note 6 for September 1951 regarding John Cook. After resigning he registered as a Rover Scout with the 70th.
- 12. See note 7 for September 1951 regarding George Crawford. After resigning he registered as a Rover Scout with the 70^{th} .
- 13. The appointment of a new Troop Leader may well have been postponed for a year until the start of the 1953-54 session. Andrew Whiteford was certainly Troop Leader by November 1953, but it is known when he was appointed, other than it was after February 1953.
- 14. John Ross probably joined the Troop in April or May of 1950. He might have transferred from another Troop as he was speedily promoted to Second in June 1951. Although he missed out on promotion in September 1952, he was promoted to PL of the Seagull Patrol in November 1952.

 15. It is believed that Jim Whitefield joined in April or May of 1950, and that he had been recruited
- without having being a Wolf Cub. He was promoted to PL of the Curlew Patrol in September 1952

and was possibly aged 14 at the time. He was a member of the football team that lifted the District trophy in 1952 and was a member of the 70ths B team for the Signalling Competition held in 1952.

16. Neill Cook was a member of the Douglas Brown's Six in the Wolf Cub Pack. He joined the troop in January 1951 and ended up in Douglas Brown's Patrol at one point. He was aged about 13 when he was appointed as Second of the Seagull Patrol, then became PL of that patrol in May 1954. At one point Neill had the most Proficiency Badges of any Scout in the Troop. As a result he was joint winner of the Coronation Cup for Best Scout for the 1953-54 session.

- 17. Willie Bain was a Sixer in the 70^{th} 's Wolf Cub pack and probably moved up to the Troop during September 1949. Although he missed out on promotion in September 1952, he was promoted to Second of the Wolf Patrol possibly in November 1952. Willie was a member of the successful District team that won the Ambulance trophy in 1953.
- 18. Troop numbers were steadily rising during the early 1950s. At the end of 1949, there were only three patrols (Seagull, Seal and Wolf). At the start of 1950, the Curlew Patrol was reinstated to form four Patrols. In June 1951, a two further Patrols were added (Fox and Falcon) resulting in 6 Patrols for the first time since the Troop's 'rebirth' in 1947. At this stage there were 32 Scouts present in the Troop. The last time that 6 Patrols might have existed was during the 1930s. A Troop Photo taken in the late 1930s indicates at least 34 Scouts at that point.
- 19. It is not known what the medallions looked like or over how many years they were presented. None appear to have survived.

The Annual subscription (which is 5/- per scout⁷) was handed in to the A.S.M.¹ by each P.L. at the beginning of the court. Then the A.S.M. announced that S.M. Clark⁸ was to be married on 27th December⁹. The court then chose 12 members of the Troop to form a Guard of Honour at the wedding¹⁰. It was decided to buy the S.M. a wedding present¹¹ so P.L.s. D. Brown, A. Whiteford and A. Duncan were elected to form the wedding committee.

To raise funds for the troop, it was suggested to have a Beetle drive¹² in December but this was left aside at the moment as there was plenty of time to arrange something.¹³ Douglas Brown (P.L.)

- 9. Victor Clark married a German nurse called Hannelore Zinnerman. Apparently they met when Victor was recovering from a recurrence of tuberculosis (TB) which originally affected him at some point during the 1930s. Tuberculosis was an airborne transmission and was not unusual during the 1930s and 1940s. It was only in the late 1940s that effective treatments started to be discovered. Catching TB could be fatal and those that survived often suffered recurrences of the disease. The fatc that Victor had caught TB meant tat he was not called up during the 2nd Wold War.
- 10. The original 12 members chosen is not recorded. On the day, there were 11 present consisting of Sandy Jack, Sandy Whiteford, John Heap (Sec.), John Ross (P.L.), Alistair Duncan (P.L.), Willie Bain (Sec.), Douglas MacNeill (P.L.) Robert Miller, Douglas Brown (P.L.) Jim Whitefield (P.L.) and Andy Whitefield (P.L.)
- 11. The wedding present from the troop ended up being a 24-piece canteen of cutlery and a case of fruit spoons. Andrew Whiteford acted on behalf of the troop and presented the present to Victor and his future on the 17th December 1952. Victor and his wife showed their appreciation by laying on a party for the Scouts in January 1953.
- 12. Beetle Drives were a popular party event during the 1950s and 1960s. Each player had a card on which to draw a beetle made up of a body, head, two feelers, two eyes, two wings and six legs. The players sat at different tables, four players to each table, and the dice was continually passed round the table such that each player could throw. Each player had to first throw a 2 in order to raw a body, then a 1 to draw a head. After that, the body parts could be drawn in any order by throwing a 3 for each feeler, a 4 for each eye, a 5 for each wing and a 6 for each leg. The first person to compete the beetle shouted "Beetle' and that mean everyone had to stop. Everyone then added up their score depending on what they had managed to draw. A complete Beetle was worth 63 points, based on the values of each part of the body. There was room on each side of the Beetle card to have 12 games, and so the overall winner was the player with the highest score overall.
- 13. According to the Troop Log, a Beetle Drive was held on 6th March 1953 for parents and friends. Presumably, too much was going on in December to organize the Beetle Drive then.

The question of new headquarters was brought up again tonight⁶. A.S.M. Hodgson proposed that the troop should buy a hut and convert it into headquarters. It was decided to send away for prices of suitable huts. Next came the question of what to do with the stamps⁷ which Mr Stewart, the minister⁸, has generously given to the troop. After a short discussion, it was decided to make them up in packets of about thirty stamps and sell these packets among the troop. The court could not decide on the charge to be made for them, so this will be done later.

V. Clark¹ announced to the court that he had taken out a warrant as Group Scoutmaster, as, owing to pressure of business⁹, he would be unable to come to troop meetings every Friday night.

Editorial Comments for 23rd January 1953

- 1. Victor J. Clark had been Scoutmaster (S.M.) since restarting the 70th Troop in 1947. He had also been a 70th Scout throughout most of the 1930s. After his marriage in December 1952, Victor resigned as Scout Master and took out a warrant as Group Scout Leader. It is estimated that he was aged about 32 or 33 in 1954. He occasionally dropped in at Troop Meetings to keep in touch with what was going on. Due to a lack of records during the mid 1950s, it's not known when Victor resigned from the Group, but it appears likely that it was in the summer of 1958.

- 6. The topic of finding a hut as a Scout HQ had previously been discussed in September 1953. However, the huts discussed here appear to be different from those discussed on that occasion. As seen in the entry for 20^{th} February 1953, the huts discussed on this occasion had to be erected on a suitable site.
- 7. It's not known whether these were The Rev Stewart's own stamps or whether a collection had been donated to the Church. Stamp Collecting was a much more popular hobby amongst boys during the 1950s than it is now an most Scouts had some kind of stamp collection. When Scouters filled in Scout Progress cards, it was almost standard to add 'Stamp Collecting' under the 'Hobbies' section.
- 8. The Reverend Stewart took over the ministry of Finnart Church in the mid 1930s and continued to be minister into the late 1960s. He played a key role in keeping the Group going during the War by carrying out essential administrative duties for the group, such that the available leaders could focus on running Scout programmes. After the war, he probably spent a fortune during the newly introduced Bob-a Job weeks providing gardening tasks for eager Boy Scouts who probably pulled out as many flowers as weeds.
- 9. Victor Clark was a timekeeper at one of the many Shipbuilding Firms that were in Greenock during the 1950s.
- **10**. P.L. Douglas Brown wrote up the COH minutes, and this was checked at a later date by Brian Hodgson.

A very short meeting of the court was held tonight after the weekly troop meeting. A.S.M. Hodgson stated that he had enquired about prices of huts⁷ as the troop is needing new headquarters and a reasonably sized one would cost approximately £300 8 to buy initially without cost of ground, erection etc. To help raise funds, the troop is to run a Beetle Drive 9 on Friday, 6th of March, 1953 10 . Tickets are to be printed, price $2/6^{d11}$ and tea will be served. Membership of the troop now totals 34 scouts.

Because some patrol flashes¹² are lost during games, to of these required by each patrol was taken by the A.S.M.¹³ and he will send away for them.

Planning ahead, the court decided that the troop would hold a Bring and Buy Sale¹⁴ in March¹⁵ and the Coronation Dance¹⁶ is to be held, provisionally on the night of Tuesday, June 1st.¹⁷

- 13. It's not clear what is meant here. Possibly two samples of the flashes used by each Patrol were taken by the A.S.M. so that he could send these off to suppliers to indicate what colours were required.
- 14. It's not stated what was involved in a Bring and Buy Sale. Presumably, it involved selling goods and produce either made by or donated by friends and relations to the same social circle. It is likely that this would have included a used book stall, home baking, second hand toys, plants etc. Possible a 'Bring and Buy Sale' was similar to a 'Sale of Work', which was another event that was organized to raise funds. The advantage of a 'Bring and Buy' or a 'Sale of Work' over a Jumble Sale might have

been that it was easier to organize and required less preparation. However, less money was likely to be raised

- 15. There is no record of a Bring and Buy Sale taking place in March 1953. However, that cannot be taken as evidence that it did not take place. Events outwith the normal Troop meeting were not always recorded.
- **16**. The Coronation Dance was to be organized as part of Scout Week to celebrate the coronation of Queen Elizabeth II.
- 17. The Coronation Dance did indeed take place in the Church Hall on the 1st June 1953. However, it was not judged a great success as only 10 or 11 couples were present (Troop Log). It was not stated whether the dance was for Scouts and Guides only, or for Scouts, Parents and Friends.
- **18**. P.L. Douglas Brown wrote up the COH minutes, and this was checked at a later date by Brian Hodgson.

Investitures¹⁰

P.L. Brown⁴ suggested that a system should be arranged for investitures. The arrangement decided upon with this;- the P.L. holds the recruit's elbow and they walk forward without formality. After the investiture, the P.L. gives the 'about turn' and they walk back together as before.

Christmas Sale

The day of the Christmas sale was arranged as December 5th¹¹. Details were arranged, each P.L. being given instructions about his stall.

Second

A new second for the Fox Patrol was necessary after the transfer of Robert Miller¹² to the Falcon patrol. Neville Mort¹³ was found most suitable and was unanimously elected.

- 6. Sandy Whiteford started his Scouting in Rothesay, then transferred to the 70th when his family moved to Greenock in late 1951 or early 1952. He initially joined the Seal Patrol then moved to the Fox Patrol, before he was promoted to Patrol Leader of the Seagull Patrol in May 1953 the only 70th Scout known to have been promoted to P.L. without previously being a Patrol Second. He is also the only 70th Scout known to have transferred to another Patrol as P.L., which he did when he took over the Falcon Patrol in May 1954. Sandy was promoted to Troop Leader in October 1955 at the age of 16 and remained as T.L. until October 1957, when he became an A.S.M. Sandy gained his Queen's Scout Badge and was awarded his certificate by the Chief Scout in June 1954, at the same time as his brother, Andy.

- 7. Ian McFarlane was a member of the Wolf Cub Pack during the late 1940s and it is believed that he joined the Troop during the second half of 1949. He was placed in the Seal Patrol, then the Curlew Patrol, before he was promoted to Second of the Falcon Patrol in 1953. However, within a few months, he was promoted to Patrol Leader of the Fox Patrol at the age of 15, replacing Ian Campbell. In September 1954, Ian resigned as PL to become Troop Leader for the 1954-55 session. In 1954, Ian gained the Coronation Cup for 'Best Scout of the Year'. Ian eventually resigned as Troop Leader in the second part of 1955 when he would have been 17, then served as an ASM from 1956 to 1963.
- 8. Although the COH minutes were not written up from the end of February to the start of November, P.L. Ian Campbell is unlikely to have been responsible for most of those omissions as he was probably promoted in the summer of 1953.
- 9. It is thought that Ian Campbell might have transferred to the 70th from another Troop in 1950 or 1951 when he was 14 or 15. By September 1952 he was Second of the Fox Patrol and at some point during the summer of 1953, he took over from Alistair Duncan as PL of the Fox patrol. However, by November of 1953, he had left the troop to join the Rovers.
- 10. The Investiture ceremony has probably changed very little during the history of the troop. During the 1960s, a table was brought in to the hall and a Union Flag laid on top. Candles were lit and placed on the table and the main lights were put out such that the only light came from the candles. The boy who was due to be invested was then instructed to march to the table by his PL, who stood at the alert a few paces behind. The boy stood on one side of the table, while the Scout Master (SM) stood on the other side. The SM then asked the boy if he knew 'what it meant to be put on your honour', to which the boy replied something along the lines of 'A Scout is to be Trusted'. The SM then asked the boy to place his left hand on the flag and to make the Scout sign with his right hand. The SM then asked everyone else present to make the Scout sign before asking the boy to repeat the Scout Promise after him. Once this was over, everyone stopped showing the Scout sign and the boy was welcomed into the 'Worldwide Brotherhood of Scouting' and presented with his neckerchief and various badges. The SM shook the newly accepted Scout by the left hand and they both saluted. The Scout's PL then commanded the new Scout to 'about turn' and march back to the patrol. At some point during the years that this ceremony was carried out, the parents of those boys getting invested were invited along to witness the ceremony, but it is not known when exactly the practice was introduced or whether it occurred at all during the 1950s and 1960s. An interesting aspect of the ceremony involved the PL identifying the boy by name only when instructing him to march to the table. Once the ceremony was over, he added the title 'Scout' when ordering him back to the patrol. The ceremony may well have been slightly different in the early 1950s. For example, a Scout investiture described in November 1950 was carried out in the main church, rather than the Church Hall. As far as Wolf Cub investitures are concerned, they were held in the main church during the late 1940s, 1950s and 1960s.
- 11. This had to be postponed (see COH minutes for 29th November 1953).
- 12. Robert Millar joined the Troop before the summer of 1951 and might have transferred from another Troop. He was placed in the Curlew Patrol and remained in that Patrol until 1953 when he was promoted to Second of the Fox patrol. He was then transferred to become Second of the Falcon patrol. In March 1954, he was promoted to PL of the Curlew Patrol, but did not remain long as PL. In June of that year, he resigned to join a Bull Patrol that was meant to help lead the troop when Brian Hodgson resigned. However, when Brian eventually resigned, Bob became an Acting ASM. Bob successfully completed his Queen's Scout Badge in 1954 and received his certificate from the Chief Scout. He was also part of the team that won the District Signalling Competition in 1953. Bob remained with the Troop as ASM and SM until 1966, thus completing a distinguished 15 years with the 70th Troop as Scout, Patrol Leader, ASM and SM.
- 13. Neville Mort was the son of Greenock's police chief. He attended Greenock Academy and was in the 70th Wolf Cub Pack. He joined the troop in June 1951 and was placed in the Seagull Patrol. In September 1952, he moved to the Wolf Patrol, then in November 1953, he was promoted to Second of the Fox Patrol. In March 1954, it is believed that he transferred to the Falcon Patrol as Second, then in May 1954, he became P.L. of the Curlew Patrol at the age of 14. He was part of the 70th signalling team that won the District Signalling Competition for 1953. He also represented the 70th at the Scout Sports Day at Cappielow in 1953.
- **14**. Note that the Wolf Patrol was disbanded at the beginning of September 1953, presumably coinciding with the resignation of P.L. John Heap.

Whist Drive

Unfortunately, Mrs. Stewart⁹ had requested that the troup¹⁰ postpone their Christmas sale¹¹, as another was been held in the church shortly afterwards. Owing to this, another means of raising money had to be found. A whist drive was popular, but permission would need to be obtained from Mr. Stewart¹². It was decided that the parents should take a table, price 10/-¹³ and bring three other persons to make four per table. A pack of cards will be necessary for each table. It was suggested that a raffle be held also. Tickets would be sold before the whist drive and the draw would take place at the whist drive on Wednesday 16th December¹⁴. A committee was formed to arrange the whist drive, *n*amely the A.S.M.³, T.L⁴. and P.L. Brown⁵ while the other P.L.s along with the S.M.² were to take charge of the raffle. 300 tickets will be required and will be written out by the three P.L.s of the raffle committee.

Green Shirts¹⁵

Green shirts are now to be worn by all new recruits when they join the troup¹⁰. This will smarten up the troup a bit.

Patrol Meeting¹⁶

Each patrol is to hold a meeting among themselves, between now and Christmas to get on with some work. This will bring the patrols together and it will be recorded in the patrol logs.¹⁷

Hikes

There have to be two hikes during the Christmas holiday on the 28th-29th December and 4th-5th January¹⁸. Second class and first-class courses will be held on the hikes.¹⁹

Summer Camp

A summer camp is to be held. It was decided that near Perth would be suitable and it was arranged that a letter should be sent to the County Secretary of Perth enquiring about campsites. It will last ten days from the $16^{\rm th}$ - $25^{\rm th}$ July. Good Turn

The court decided that the Christmas good turn by the troup should be the giving of toys to the hospitals.²¹ Each P.L. will gather them from his patrol then report to the T.L.⁴

Editorial Comments for 29th November 1953

- 1. The Court of Honour was held at Brian Hodgson's parental home of 81 Newton St., Greenock.
- 2. Brian Hodgson was identified as a P.L. at the start of 1950. However, he was not in charge of a patrol and it is believed that he was acting the role of Troop Leader. It is possible that he was not yet old enough to be promoted as such. He was officially promoted to Troop Leader in September 1950, then to A.S.M in January 1951. It is estimated that he was aged 17 in 1951. He took over the Troop as de facto Scout Master at the beginning of 1953, but was not officially identified as Scout Master until he gained his warrant during the summer of 1953.

- 14. There is no record of the Whist Drive taking place on the 16^{th} December in either the Troop Log or the Seal patrol Log. However, both logs focused mostly on troop evenings and so it is quite possible that the event took place and was not reported.
- 15. Khaki uniform shirts were also available. Troop photographs indicate that the troop wore green shirts in the 1930s and that a number of Scouts were wearing khaki shirts during the war years. It is possible that the Scouts concerned had moved to the local area during the war from other parts of the country. Alternatively, khaki shirts might have been easier to obtain at a time when uniform clothing was less available. The Troop Photo taken in December 1953 shows the variety of uniform shirts being worn at that time with about 13 Khaki shirts and 14 Green shirts.
- **16**. Patrols were encouraged to have patrol meetings and activities, separate from the weekly troop meeting.
- 17. It is likely that most of the Patrol Logs written during the 1950s are either in the possession of ex Scouts or have been discarded. Only two Patrol log books have been identified to date. One is the Seal Patrol Log covering 1953-5 in the possession of Kenneth Conway. The other is the Fox patrol Log covering 1955-59.
- 18. The hike scheduled for the 28^{th} - 29^{th} December 1953 took place and is described in the Troop Log. It involved three Senior scouts and included a hill climb over Ben Chaorach from Glen Luss. Possible participants were John Cook, David Slater and Andy Whiteford. There is no record of the hike scheduled for the 4^{th} - 5^{th} January 1954 though..
- 19. It's not clear what is meant by 'Second class and first-class courses' being held on the hikes.
- 20. There is no record of a Summer Camp being held in the 8 years following the restoration of the 70th Troop (1947-54). This is not altogether surprising as Victor Clark was the only warranted leader present during most of this period and his health might have precluded him committing himself to a prolonged camp. There is a possibility that 70th Scouts might have attended Summer Camps with other Troops during this period, but there is only circumstantial evidence to back that up. Therefore, the proposed camp to Perth in July 1954 would have been a major step forward in terms of camping experience. Unfortunately, the camp did take place, possibly because Brian Hodgson was convinced by his parents in 1954 to take a step back from Scouting in order to focus on his academic studies. Therefore, the first major Summer Camp to take place since the Troop's revival was the Summer Camp to Inveraray in 1955.
- 21. The 70th's Christmas Good Turn was probably inspired by a similar Good Turn that was carried out by the Troop during Scout Week in May 1953 see the entry in the Troop Log for 25th May 1953. The donation of books and toys to children in hospital as a Christmas Good Turn became an annual event that continued well into the 1960s and possibly beyond. See also the COH entry for the 5th November 1954.
- **22**. P.L. Ian McFarlane wrote up the COH minutes, and this was checked at a later date by Brian Hodgson.

It is thought that Robert may have been appointed as Second of the Fox Patrol at the same time, replacing the existing Second who moved to the Falcon Patrol to replace

Stanley Bacon. In May 1954, Robert became Second of the Curlew Patrol. Note that there is a possibility that Robert may have had a Second's stripe from his previous Troop. Robert was promoted to PL of the Curlew Patrol, possibly at the end of June 1955.

- 11. Jimmy Miller was first mentioned in the available records as being a member of the Seagull Patrol round about the Spring of 1953. He was transferred to the Curlew Patrol, then to the Seal patrol, then to the Falcon Patrol. He was last mentioned in the records on the 5th November 1954 and it is assumed that he left fairly soon after that.
- 12. It's not entirely clear what is meant by this. Jimmy Miller was one of the younger Scouts in the Troop, so it is unlikely that he was replacing any role that Stephen might have had in his normal patrol. It is more likely that Stephen had to move out of his usual patrol to become Acting PL of the Curlew Patrol, and that Jimmy Miller was temporarily transferred to Stephen's normal Patrol to balance up patrol numbers.

- 9. Patrols were frequently encouraged to have patrol meetings and activities, separate from the weekly troop meeting. It's not recorded in any of the available records what the five outdoor activities were or whether they took place.
- 10. The County Flag Competition has been a major Scouting Competition for many years and still runs. The 70th was selected by the District to compete in it during the 1930s and had mixed fortunes. The troop performed very well in the first year that it entered, but in a subsequent competition, the examiners criticized the Church Hall for being too small for Troop Meetings. This was true but there was nothing that the Troop could do about it and so they opted out of the competition for the rest of the 1930s and 40s. In fact, 1954 appears to be the first time that the 70th agreed to compete again. The Competition involved District Commissioners selecting which Troops in the District would go forward for the Competition. Once chosen, each Troop would be visited by Area Commissioners, who would judge the quality of a 'typical' Troop meeting and interview the Scouts (see troop log for 26th February 1954). This, it appears, was a prelude to a further selection process that would identify which Troops would attend a camping weekend that would presumably assess the quality of camping, hiking and Scoutcraft in the Troop. Four Patrols from each Troop were asked to attend. In 1954, only 3 Troops were selected to attend the final weekend, and the 70th was one of the three selected. The troop performed extremely well and came second overall. Some details relating to the hike carried out during the final weekend assessment are included in the Troop Log (see 5^{th} - 6^{th} June 1954).
- 11. The 6^{th} Renfrewshire, 1^{st} Gourock (Colonel Darroch's Own). The 70^{th} had a historical relationship with the 6^{th} as the 70^{th} 's first Summer Camp in 1933 was a joint one with the 6^{th} at Ardrishaig. There was also a period when the Troop held occasional joint troop meetings with the 6^{th} .

- 13. The Group Scout Master's Cup was initiated in the 1930s by G.S.M. Ian Dunlop, who had been the Troop's second Scout Master, before becoming an active G.S.M. Ian Dunlop was invited to give the sermon at the Church service held to celebrate the Troop's 21st anniversary (see troop log 10th October 1954)
- **14.** The competition focused on semaphore, which was a strong point in the 70th. The Troop won the District Signalling Competition 8 years in a row during the 1950s.
- **15**. The 5th February 1954. Douglas Brown won on the night, with Sandy Whiteford second, and Neville Mort third.
- 16. Soap Box Derby's were very popular during the 1950s and 1960s and probably started in the US. At one time there was several Scout Soap Box Derbys. They initially involved home-made 'cars' made out of soap crates with four wheels attached. They contained no engine and they were raced downhill, letting gravity do its work. However, pedals and gears scavenged from old bikes could be included to provide pedal power. The races could attract large crowds. The Morecambe Guardian for the 6th September 1955 described a Scouts' Soap Box Derby that attracted 10,000 spectators. There were separate races for Wolf Cubs and Boy Scouts, with speeds of up to 20 m.p.h. being attained. Soap Box Derbys still take place but the designs of the machines are a bit more high tech. 17. There had been a lively debate during the 1930s as to whether Scottish Scouts should be allowed to wear the Glengarry instead of the traditional Scout hat, commonly referred to as the lemon squeezer. Baden Powell was against this proposal and pointed out that Scottish Scouts already had a distinctive uniform as they had been permitted to wear the kilt. As a result, no change was made in terms of headgear during the 1930s or the 1940s. However, it was clear that the issue had not gone away and it appears that in 1954 Scottish HO was now canvassing Scottish Scouts for their opinion. As far as the 70th Scouts were concerned, there seemed to be a significant opposition to the traditional hat, possibly because it was unwieldy and difficult to keep in shape. This opinion seemed to be generally felt throughout Scotland as Scouts were allowed to wear berets in 1955. As far as the colour was concerned, the Scouts wore a light green beret, while the Scouters wore a black Glengarry. As a result of changing to a beret, the silver coloured metal badge that PLs wore on the front of their hat was changed to a cloth badge. Although most troops probably changed to the beret, there appeared to be some latitude in terms of the traditional hat, such that Troops that wished to keep it could do so. The 45th Renfrewshire was one such group and continued to wear the traditional hat well into the 1960s. It's not known whether a change in headgear took place in England at this time.
- 9. The Wide Game that was played on the 19th February was explained in some detail in the entry for that night in the Troop Log. It involved each Patrol following a series of coded messages in order

to visit a series of locations in the local Neighbourhood. The first Patrol back to the Hall after completing it was the winner.

- 9. Bob-a-Job week was introduced in 1949 and proved a huge success (especially during the 50s, 60s and 70s) both in terms of fund raising and Public Relations. . The 'Bob' referred to the shilling that was requested for each job carried out, and the name was changed to 'Scout Job Week' following decimalisation and the demise of the shilling. In 1949, a shilling was the equivalent of £2.25 today (as of 2023). Although each job was supposed to cost 1/-, many householders paid significantly more than that. During Bob-a-Job Week, it was normal for individual Scouts to go round as many houses in their neighbourhood as they could, regardless of whether they knew the householders or not. Scout Job Week eventually stopped in 1992. By that point, society had changed and it was considered unsafe for Scouts to fund raise unsupervised.
- 10. Ian McKenzie was recruited into the troop at the beginning 1953 and might have transferred from another troop. He remained in the troop until 1956 and was a member of the Fox, Seal and Falcon Patrols. In September 1955, he was promoted to Second of the Kingfisher Patrol but was

further promoted in November 1955 to PL of the Falcon patrol. He was still attending Court of Honour Meetings at the end of April 1956, and probably resigned over the summer of 1956.

The others on the leader team were more properly assigned as Acting A.S.M.s and were probably barred from taking out a warrant as they were presumably still within the Scout age range. In fact, Clark's services were not required as Ian Blake took over as Scout Master after the summer. It is assumed that Clark reverted back to helping out at the Wolf Cub Pack.
- **11.**To be specific, replacements would be needed for Andrew Whiteford (Seal), Bob Miller (Curlew) and Douglas Brown (falcon), who would all be resigning as P.L.s.
- 12. P.L. Ian McFarlane wrote up the COH minutes, and this was checked at a later date by Brian Hodgson.

- 8. The Queen's Scout Badge was the highest award in the progressive Scout Training Scheme (Tenderfoot, 2nd Class, 1st Class, Queen's Scout Badge). To gain the Queen's Scout Badge, it was necessary to gain the Venturer's Badge, a certain number of Proficiency Badges, and the Bushman's Thong. As far as is known in terms of the 70th Troop, the Queen's Scout Badge was only ever gained by Patrol Leaders.
- 9. All five P.L.s gained their Queen's Scout Badge and were awarded with their certificates by the Chief Scout (Lord Rowallan) on 19th June 1954. It is known that Andrew Whiteford completed the Badge in December 1953. Therefore, the three PLs concerned on the 21st May 1954 must have been three of the remaining four PLs (Bob Miller, Ian McFarlane, Sandy Whiteford, Douglas Brown).
- 10. It was normal in the 70th during the 1950s and 1960s to celebrate any notable achievement by 'ducking' the Scout or Scouter concerned after the meeting was over. This could involve dragging the 'victim' into the kitchen and holding his head under the tap (or various variations thereof). The practice of ducking seemed to fade away once the Troop moved into the new Scout HQ in the late 1960s.
- 11. The Bushman's Thong was one of the requirements that needed to be earned before gaining the Queen's Scout Badge. It involved gaining three Senior Scout Proficiency Badges, as well as the Venturer Badge. The thong itself had to be made by the Scout and

was made from leather.

- 12. See Note 10 for the 22^{nd} January 1954 regarding the County Flag Competition.
- 13. The final weekend of the competition was on the 5^{th} - 6^{th} June 1954 (see Troop Log). The 70^{th} was one of only three Troops invited to participate following a selection process that lasted 5 months. All three Troops were to send 4 Patrols for the final weekend. Full details of what took place are not known, but the hiking instructions that were provided are included in the Troop Log. The 70^{th} performed well and came second.
- 14. It is not known which P.L. was left out. It's also not known whether 4 of the 5 normal Patrols took part or whether the Troop could make up 4 Patrols from the Scouts available in the Troop.
- 15. Presumably, this meant camping equipment. It also seems likely that the 70^{th} would have had to borrow tents from other Troops as the troop probably only owned 2 Patrol Tents and 3 small hike tents at the time.

- 18. In fact, 3 PL's were needed to fill vacancies in the Seal, Falcon and Curlew Patrols.

- 20. Graham White was present in the Wolf Cub Pack photograph taken in 1949, and probably moved up to the troop in the Autumn of 1951 to join the Wolf Patrol. During the 1952-53, he was in the Seagull Patrol, and was then promoted in September 1953 to Second of the Seal Patrol. In May 1954, Graham became P.L. of the Seal Patrol at the age of 14. Graham gained an impressive 'clutch' of proficiency badges, with only Neill Cook earning more. As a result, Graham was a runner up for the Coronation Cup of 1954. Graham was a member of the 70th football team that won the District trophy in 1952, and he represented the troop in the Scout Sports Day held at Cappielow as part of 'Scout Week' held to celebrate the coronation of Queen Elizabeth II. He was also a member of the 70th teams that won the Ambulance (First Aid) Competition and Signalling competition in 1953.

- 23. Neville was the new P.L. for the Curlew Patrol, taking over from Bob Miller.
- 24. It is believed that David Graham joined the troop in May or June 1951. He was initially placed in the Seal Patrol, then moved to the Seagull, Falcon and Fox Patrols before returning to the Seal Patrol. There is some evidence that David was a bit of a handful when he was younger, which might explain the frequent transfers. He missed out on promotion in May 1954, and it is not known when he was eventually promoted to Second. One possibility is that he was promoted to Second of the Seal Patrol when Jim Harvey was promoted to PL of the Kingfisher Patrol. However, it is known that he was promoted to P.L. of the Seagull Patrol in January 1956. He resigned from the Troop in February 1957, possibly once he turned 17.
- 25. Alastair Shearer joined the Troop during the first half of 1951 and was promoted to Second of the Falcon Patrol In June 1954. He was promoted to P.L. of the Seal Patrol in mid 1955, replacing Graham White. He remained as P.L. until October 1956, then presumably became a Junior A.S.M. He completed his Queen's Scout Badge at the end of March 1957, and was also one of the 70th Scouts attending the World Jamboree at Sutton Coldfield that year. Alastair was a member of the 70th football team that lifted the District Football trophy in 1953. He was also a member of the 70th team that came second in the Shannon Cup in 1957. Alastair was with the troop as Scout, P.L. and A.S.M from 1951 to 1959.
- 27. Robin McGill was nicknamed Blondy because of his hair. He had been in the 70^{th} 's Wolf Cub Pack and probably moved up to the troop during 1951 where he was placed in the Seagull Patrol, then the Fox Patrol. He was promoted to Second of the Fox Patrol in May 1954, and was then promoted to PL of the Patrol in September 1955 at the age of 15. Robin was a highly popular PL amongst his Scouts and the Fox Patrol Log stated that his resignation in March 1956 was 'a very unhappy day'.
- 28. Jim Harvey joined the 70th troop during February 1953 and was probably aged 12 or 13 with no prior Scouting experience. It is believed that he initially joined the Seal Patrol, but was transferred to another patrol at the start of the 1953-54 session. However, he returned to the Seal Patrol as its Second in June 1954. In September 1955, Jim left the Seal Patrol to become P.L. of a new Patrol (the Kingfisher Patrol). It seems highly probable that Jim gained his 1st Class Badge, but it is not known whether he gained the Queen's Scout badge. He resigned in October 1956 to become a junior ASM but was still qualified to lead the 70th Patrol that came second in the Shannon Cup of 1957. Jim remained with the 70th as an A.S.M. until October 1960.

- 31. The fund was set up in 1953 to raise a million pounds in order to fund essential restoration work on Westminster Abbey. It attracted widespread publicity both within the UK and overseas. A commemorative stone to William Caxton was placed in the Abbey in 1954 to 'commemorate the great assistance rendered to the Abbey Fund by the English Speaking Press throughout the world'. It was predicted in 1954 that the necessary repairs would take 10 years to complete.
- 32. £1 in 1954 was the equivalent in value to £35 today (as of 2023).
- 33. 10/- (ten shillings) in 1954 was the equivalent in value to £17.5 today (as of 2023).
- 34. The sections would have been the Wolf Cub Pack, the Boy Scout Troop, and quite possibly the Rover Scout Crew making a total of 18/-. The remaining 2 shillings required to make up the £1 suggests that two warranted Scouters contributed (presumably Brian Hodgson and Clark Millar).
- **35**. It is not known whether this refers to the Scout Shop in Elmbank, Glasgow, or to a more local Scout Shop in Greenock that might have existed at the time.

The S.M.² suggested charging sixpence¹⁵ from each boy who camps at Everton¹⁶ and keeping the extra three pence for troup¹⁰ funds.

The chairman asked the P.L.s to find out if the Coronation brochures¹⁷ were paid for.

The lettering on the G.S.M.'s cup¹⁸ has still to be paid for.

Court of Honour

The PLs have to inform the chairman³ of anything which has to be brought up at the Court of Honour before the meeting.

The Court of Honour will meet on Sunday afternoons when the chairman considers it necessary.

The general meeting¹⁹ will be held in May at the end of the session.

The chairman³ closed the court withdrawing the knife.²⁰

Editorial Comments 31st May 1954

- 1. The Court of Honour Meeting was held at 81 Newton Street, the home of Brian Hodgson and his parents.
- 2. See Note 2 for the 29th November 1953 regarding Scout Master Brian Hodgson
- 3. Douglas Brown was Senior Sixer in the 70th's Wolf Cub Pack and was 'head hunted' from the 59th by Betty Nelson when she restarted the Pack in 1947. Douglas moved up to the troop at the start of the 1949-50 session. He was promoted to PL of the Falcon Patrol in June 1951 at the age of 13 and remained PL for 3 years until May 1954. At that point, he resigned as P.L. and was appointed Troop Leader. However, he was only T.L for a few months as in September 1954, he resigned to become an Actina A.S.M.
- **4.** See note 6 for 6th November 1953 regarding P.L. Sandy Whiteford.
- 5. See note 7 for 6th November 1953 regarding P.L. Ian McFarlane.
- 6. See note 20 for the 21st May 1954 regarding P.L. Graham White.

- 8. This was probably just a formality as it was normal practice for the Troop Leader to be Chairman of the Court of Honour. Douglas had just taken over as Troop Leader from Andrew Whiteford, who was now an Acting A.S.M.
- 9. The 'Troop library' consisted of a number of Scouting books that were presumably kept in a box and lent out to Scouts. The books would have included ones that related to the passing of Tenderfoot, 2^{nd} Class and 1^{st} Class tests, as well as Proficiency Badges. In the 1950s, there was no internet or home computers and the only way one could obtain of information was from books and libraries.
- **10**. The Scribes for both the Troop Log and the COH minutes tended to spell 'troop' as 'troup' during this period.

- 15. Before decimalisation, there were 12 pennies in a shilling and 20 shillings in a pound. 6d corresponded to sixpence (also called a tanner). In 1954, sixpence was the equivalent in value of £1 today (as of 2023).
- **16**. This suggests that it might have been fairly common for the Scouts to camp at Everton on weekends. Unfortunately, only a vary few Everton Camps were described in the Troop Log.
- 17. This might refer to the Coronation Brochures that were printed in 1953 to give a summary of the Troop leading up to Coronation Day (2nd June 1953). It is not known when exactly those brochures were written, but it must have been before Scout week (20th May-2nd June) and after 19th April 1953 following Bob-a-Job week of Easter 1953. However, it is odd that the issue of payment was being discussed a year later, and so another possibility is that these were official Coronation Brochures that had been printed after the Coronation.
- 18. See note 13 for the 22^{nd} January 1954 regarding the G.S.M.s Cup. The Cup was won by Douglas Brown on the 5^{th} February 1954. Presumably, the lettering was the inscription of his name on the Cup.
- 19. This implies that this particular meeting was the general meeting. It also suggests that the end of May marked the end of the Scout year, which might explain why promotions were often made in June, rather than August or September.
- 20. It is not known what the 'knife' was or what it represented. The only ceremonial knife identified in the records was the small knife presented to the Patrol Leader of the winning Patrol of the Month Competition. It does not seem likely that this knife should double up as some kind of symbol for the Court of Honour.

It also saw service during the 1950s and 1960s for the collection of jumble from houses in the neighbourhood.

1. A lot had changed over the summer since the last COH meeting in terms of the future leadership of the troop. It is assumed that Ian Blake agreed to take on the role of Scout Master during the

summer. As a result, there was no longer any need for Clark Miller to take out a warrant as an A.S.M, and he presumably returned to the Wolf Cub Pack as an Assistant Cub Scout Master. It was also decided that the Bull Patrol was no longer required. Andrew Whiteford, Douglas Brown and Bob Miller were no designated as Acting A.S.M.s, while Stephen Pearce became Patrol Leader of the Fox Patrol to replace Ian McFarlane who now took on the role of Troop Leader from Douglas Brown.

Editorial Comments 1st October 1954

- 1. See note 1 for the 23rd January 1953 regarding Group Scout Master Victor Clark.
- 2. It was unusual for Victor Clark to attend a Court of Honour Meeting once he became Group Scout Master. There were two possible reasons for his presence on the 1st October 1954. Firstly, this was Ian Blake's first Court of Honour Meeting as Scout Master, and so Victor may have attended to lend support. Secondly, Victor was playing an important part in the upcoming 21st Birthday Event which was discussed in detail at this meeting. It is also possible that Victor was heavily involved in the planning of the programme.
- 3. Although Scout Master Blake always signed himself as John R. Blake, he was more commonly known as Ian. Ian was probably aged about 34 when he took over the Troop in September 1954, and had been one of the first Scouts to join the 70th when it was initially formed in the 1930s. Indeed, he attended the first two Summer Camps held in 1933 and 1934. However, he left the Troop when he was 14 and there is no evidence of him being involved in Scouting after that until he became the Troop's Scout Master. He remained as Scout Master until 1959 when resigned dur to work commitments that required him to move to the West Indies.

He was Company Secretary and a Director of the Greenock Dockyard Company, and training advisor with Scotts' Shipbuilding and Engineering Company. He was on the Board of Management of Quarriers Homes, and was also a Justice of the Peace and a Sheriff Substitute. Finally, he was also a member of Greenock Methodist Church and carried out missionary work in South Africa. Nobody was in the least surprised when he was awarded the Silver Acorn for distinguished service to Scouting.
- **16**. This was a display of semaphore at which the 70^{th} excelled, dominating the District signalling competition for many years.
- **17**. Further details on '20 Questions' are provided in the Troop log for the 8th October 1954. 20 Questions was a popular panel game on the radio.
- 18. It is possible that the Scouters played the role of a patrol that got everything wrong. This is implied by the naming of a 'Muddle Patrol'. On the other hand, the Scribe of the Troop Log identified the Patrol as a 'Model Patrol. However, he may have misheard what was said.

- **20**. Edmund Thomson was the Scout that was invested on the night. However, very little is known about him..
- 21. This would have been an indoor campfire round an artificial fire made out of wood, coloured material and a light bulb.
- **22**. This was the presentation made by Victor Clark of a book and book token to ex-Scout Master Brian Hodgson.
- **23**. The Reverend Stewart gave the Benediction on the night, suggesting that he might have left the event after the beginning and returned at the end.
- **24.** See Entry 28 for the 21st May 1954 regarding Second Jim Harvey. Although he was selected for the patrol, he was not actually present on the night.
- 25. See Entry 27 for the 21st May 1954 regarding Second Robin McGill.
- 26. Hugh Kerr joined the troop in 1954. It is not known why he was chosen for the 'special Patrol', and he did not actually attend on the night.
- 27. Second Robert McKinnon and Scout Hamish Rankin were part of the 'special Patrol on the night, presumably in place of Jim Harvey and Hugh Kerr respectively. Therefore, there were 6 members of the patrol on the night.
- 28. It is not known which caterer was used.
- 29. It is not clear whether this referred to Neill Cook (Minutes scribe for the Court of Honour) or Graham White (Troop Log Scribe). One might also have expected the Troop Leader (Ian McFarlane) to write the letter.
- 30. Marjorie Gibson had been in the Girl Guides and it is believed that she joined the 70th's Wolf Cub Pack as an assistant in 1950. When Betty Nelson resigned as Akela in 1953, Marjorie took over. Marjorie was still Akela in October 1954, but may have handed over to Isabel McBride fairly soon afterwards.
- **31.** See Note 2 for the 29th November 1953 regarding Scout Master Brian Hodgson. He resigned in September 1954 as his father was insistent that he take a step back from Scouting in order to focus more on his academic studies.
- **32.** It is not known whether there was some significance behind the 'cheapies' book or what it entailed
- 33. An Honours List for 1954 was included in the Troop Log (possibly written in June) which showed that the Troop possessed the District's 'William Shearer Memorial Shield' for Signalling..

 Presumably, all the 70th's own trophies such as the GSM's Cup and the Coronation Cup were also put on display.

- 23. Presumably, the Duty Patrol was meant to bring in the notice board at the start of the meeting and return it to wherever it was stored after the meeting. If, so, this was clearly not being done and David Slater was insisting that it should.
- **24**. Discussions on finding a bigger hall to meet occurred off and on from the 1930s. For example, the matter was discussed in September 1951, 23^{rd} January 1953, and 20^{th} February 1953.
- 25. The exact location of the hall at Cardwell Bay was not identified. However, it might have been on the left hand side of Manor Road just up from Cardwell Bay, before the bridge over the railway. There used to be a church mission hall on the left hand side there which the 70th occasionally used for jumble sales. It was eventually demolished and a garage was constructed on the site. It, too, was demolished and a set of flats are now on the site., which was knocked down.
- **26**. The dinner concerned took place during the Social night held on the 8th October 1954, marking the 21st anniversary of the Troop.
- 27. The only balcony that this could have been was the balcony in the main body of the Church. The Scouts were probably placed there so that any noise they made would not be heard in the Church Hall.

First, the minutes of the previous meeting was read. And many objections were made.

The Social was decided to be held on the 1^{st} of December as the exams would be a nuisance. The P/Ls and the T/L⁶ were to do all the work. but Dave² said he would be glad to help us if we needed it.¹²

R. Millar⁵, being the old printer, was asked to give S. Whiteford⁷, the new printer, a lesson and he said the plate was made up, and only the date needed to be changed. 40 was the number of tickets decided and the price was to be 2/6.¹³ The prizes were usually donated by the parents and this was to be made known to the troop. The patrol drawn to take the tables was the Curlews.

N. Cook⁸ was unanimously voted to be the man to see Mrs. Miller¹⁴ about the eating.

D. Brown⁴ read the bill from the caterer¹⁵ and the finance of the troop read as follows:-

A Second P/L²² brought a note from his doctor, which said his health disallowed him to swim until Summer. This meant he could not be allowed to get his Scout Cords as he was 15 before then.^{23,24} The court decided that he should be allowed to pass the alternative on condition that he passes his swimming when summer came.

Editorial Comments for the 9th September 1955

- 1. This was the 1st COH meeting of the new Scout session (1955-56). It is likely that that this occurred a week before the 1st Troop meeting of the new session as no troop meeting for the 9th is mentioned in the Fox Patrol Log. Records are sparse from April-August 1955, and several changes had taken place by the start of September 1955. In particular, it had been decided that a new patrol was to be formed, taking the total number of patrols from 5 back up to 6, with Jim Harvey as the new Patrol Leader and Ian McKenzie as the Second. This took place on the 16th September 1955. Alistair Shearer was also promoted as P.L. the Seal Patrol following the resignation of Graham White, which must have occurred at the end of June 1955 or during the summer months. Neville Mort (P.L. of the Curlew Patrol) also resigned at some point between May and August 1955. The most likely time would have been towards the end of June 1955. His position as PL of the Curlew Patrol was taken over by Robert McKinnon.

Hamish resigned as PL in April 1960, by which time he had gained a reputation as an outdoor enthusiast and camping expert. Hamish attended the World Jamboree at Sutton Coldfield in 1957, and was also involved in the Shannon Cup competitions held in 1956 and 1957. The teams came 1st and 2nd respectively.

 13. This is evidence that a Troop Log was written for the period 1955-57. Unfortunately, that log
- book has not been traced.
- 14. It is not known why the Kingfisher name was chosen. In some respect, it would have been nice to have restored the Wolf Patrol as suggested at the Court of Honour held on the 26^{th} November 1954 (see note 10 for that date).
- 15. Fire and cooking had long been tested as part of the 2^{nd} Class Badge. A wood fire had to be lit without the aid of paper and with no more than 2 matches, and a simple meal was to be cooked on it, such as sausages or porridge. The reference to 'notes' is not clear. One possibility is that a parent had written a note to state that his or her son had cooked a meal at home.
- 16. This is the first indication in the available records of Isabel McBride as the 70th Akela. She was present at the 21st anniversary dinner on 8th October 1954, but Marjorie Gibson was the Akela at that point. There is a possibility that Isabel was invited to the Anniversary Dinner as she was expected to take over as Akela in the foreseeable future. However, this is no more than speculation and it is not known when Marjorie Gibson resigned as Akela. Isabel was certainly Aklea in 1955 and remained so throughout the 1950s and 1960s, and well into the 1970s.
- 17. A going ceremony was held when Cubs moved up from the Wolf Cub pack to the Scout Troop. It is not known what the precise ceremony was like in the 1950s. In the 1960s, the Scouts formed up at the far end of the Church Hall and the Cubs formed up at the other end. A rope was stratech across the middle of the hall, with Akela standing on the Cub side and the Scout Master standing at the other. Each Cub would would walk up to Akela who would introduce him to the Scout Master. The Scout Master would welcome the Cub into the Troop as he then stepped over the line. It is also possible that the Cub might have been introduced to his Patrol Leader who would then take him to his Patrol.

In November 1957, he was promoted to Troop Leader, and chose to be Troop Leader, whilst retaining his position as P.L. of the Fox Patrol. He gained his Queen's Scout Badge in March 1959, and was a member of the 70th teams that entered the Shannon Cup in 1957 and 1958. The 70th Patrol came second in 1957 and third in 1958. He resigned as T.L. and P.L. in September 1959 when he was 16 to become a 'Very Junior Assistant Scout Master'. He eventually gained a warrant as an ASM and remained with the troop until at least 1965.
- 15. Cameron Lyle is thought to have joined the Troop from the Wolf Cubs during September 1955. He was a member of the Falcon and Fox Patrols and was with the troop in April 1957. However, it has not been possible to determine when he left the troop or what he achieved when he was with the troop.
- 16. Very little is known about D. McQuat. His full name might have been David Duncan McQuat, which suggests that he might have joined the Troop from Cubs either before or after the summer of 1955. He was a member of the Falcon and Curlew Patrols, and was considered for promotion to Second in January 1956. - 1. At some point, possibly during December 1955, Andrew Whiteford and Douglas Brown resigned from he 70^{th} and became A.S.Ms with the 1^{st} Renfrewshire Scouts. However, they maintained contacts with the 70^{th} and there were a number of joint weekend camps involving both the 1^{st} and the 70^{th} . Four Scouts from the 1^{st} also participated in the 70^{th} 's summer camp to Tarbert in 1956.

The latter seems more likely, based on the list of PLs and seconds provided on the 19th October 1956. On the other hand the COH minutes for 27th April 1957 identify Ken Johnson as a Second, but not Ken Conway. It is known, however, that Ken Johnsone was promoted to P.L. of the Seagull Patrol in February 1957. Kenny was a keen camper, and was a member of the 70th team that entered the Shannon Cup competition in 1959. He was also one of the 70th's representatives at the World Jamboree held at Sutton Coldfield in 1957. He also received his Queen's Scout Badge. Ken resigned as P.L. in September 1959, when he would have been

aged about 17, and joined the ranks of the Scouters as a 'Very Junior A.S.M.' (V.J.A.S.M). It is believed that he resigned from the troop after the summer of 1963, by which time he was an A.S.M.

- 14. William Harkness probably joined the troop during 1954 or 1955, although there is no mention of him in the records until the 13th January 1956. Although he was not chosen as a Second on that date, he was chosen to be the Seagull Patrol's Second in October 1956, although the promotion did not take place until February 1957. William may have gained his 1st Class badge as he completed his 1st Class hike in April 1958. William was still Second of the Seagull Patrol when he resigned in January 1960.

- 16. It is believed that Eric Paterson joined the 70th in the latter half of 1953 at the age of 11. Eric was in the Seal Patrol and was tall for his age (see troop log entry for 29th October 1954). Other than that, it is not known how long he stayed in the troop or whether he was ever promoted to Second.
- 17. Kenneth Conway joined the troop in May or June of 1954 at the age of 11. It is possible that he was the 'Kenny' that was promoted to Second in January 1956, but there is some ambiguity over this and it seems more likely that the 'Kenny' was Kenneth Johnson. If so, it is not known when Ken Conway was promoted to Second. Kenneth was certainly promoted to P.L. of the Seal patrol in October 1956 at the age of 13, and remained its P.L. for the next 4 years. There were few instances of Scouts being P.L.s for that long, although Trevor Jones is one other example. Kenneth was promoted to Troop Leader in September 1959, but resigned in April 1960 to lead a Senior Scout Patrol. It is believed that he left the Group in the summer of 1960. Kenneth gained his Queen's Scout Badge in 1959. He also participated in the Shannon Cup Competitions of 1958 and 1959, leading the patrol that participated in 1958. The 70th came second in 1959. Kenneth's Patrol also won the Patrol of the Year Competition for the 1958-59 session.
- 18. It is stated somewhere that the 70^{th} won the signalling competition 8 years in a row. If this is accurate, then they would have won the competition in 1956. However, this has yet to be confirmed. 19. It is not known whether the 70^{th} entered these competitions or not.
- **20**. The 70th won the Shannon Cup Competition held in 1956. Sadly, there is no record of who was in the team.
- 21. The question mark was included in the minutes, suggesting that the Court of Honour might have been in two minds about entering. Due to the missing troop log book covering 1956, it is not known whether the troop entered or not.
- **22**. This refers to the monthly Patrol Championship, which also counted towards the Champion Patrol of the Year.

Editorial Comments for 19th October 1956

- 1. There are no surviving records covering the months May-September 1956. During this period, a 70th patrol that included Hamish Rankin won the Shannon Cup Competition at Everton. There was also a very wet Summer Camp at West Loch Tarbert during the 3rd-18th August 1956. At one point, the camp had to be abandoned because of flooding. There were also changes in Patrol Leaders. Robin McGill, (Fox Patrol) resigned on the 23rd March 1956, and Ian Kirk (the existing Second) became Acting Patrol Leader until October 1956. Jim Harvey (Kingfisher) was still identified as P.L. at this Court of Honour Meeting and presumably resigned on the night to become a Junior ASM.. Alistair Shearer (Seal Patrol) probably resigned during the summer to become a Junior or Very Junior A.S.M.. Ian McKenzie (Falcon) probably resigned during the summer of 1956.

Fox Patrol P.L since March. But had not actually been promoted. On the other hand, the 'Acting Patrol Leader' for the Curlew Patrol was Scott Soutar who had been appointed on the 27^{th} April 1956. Another possible explanation is that the scribe made an error and that it should have been the Seal Patrol that had an acting PL instead of the Curlew Patrol. This seems the most likely explanation, such that Hamish Rankin, John Nisbet, Trevor Jones and Kenneth Conway were all promoted from Second to PL on the 19^{th} October.

In February 1957, he was promoted to P.L. of the Curlew Patrol, probably still only aged 12. Brian gained his 1st Class Badge and Venturer Badge in 1959 and may well have gone on to get his Queen's Scout Badge. However, this needs to be confirmed. Brian also competed in the Shannon Cup of 1957, 1958 and 1959 (the 70th came second in both 1957 and 1959). He resigned in January 1960.

- 17. During the 1950s and 1960s, it was customary in the $70^{\rm th}$ to celebrate any notable achievement by 'ducking' the Scout or Scouter concerned after the meeting was over. This could involve dragging the 'victim' into the kitchen and holding his head under the tap (or various variations thereof). John Nisbet objected to this practice being carried out on Scouts gaining important badges such as the $2^{\rm nd}$ Class, $1^{\rm st}$ Class and Queen's Scout Badge. The practice of ducking seemed to fade away once the Troop moved into the new Scout HQ in the late 1960s.
- 18. This suggests that there was strong opposition to John Nisbet's proposal. Certainly, ducking continued throughout the 1960s.
